KIMEP University accepts application documents in Russian, Kazakh, or English, or with a certified translation into one of these languages.

STEP 1. SUBMIT YOUR ONLINE APPLICATION

The applicant portal is available 24/7, 365 days a year.

- 1. Fill out the online application form on the applicant portal
- 2. Upload a scanned copy of your ID card (for citizens of Kazakhstan) or passport (for international applicants).
- 3. Upload a scanned copy of your higher education diploma (with transcript)*
- 4. Upload a copy of your employment record book or CV
- 5. Upload 2 recommendation letters for applicants to the International Law (MLLM) program
- 5. Upload 1 recommendation letter for applicants to the following programs: Public and Municipal Administration (MPMA), International Relations (MIR), Educational Policy and Management (MEPM).
- 7 Digital photo

It is very important to upload your digital photo specifically in the "Photo" field, as all departments at KIMEP will use your photo from this field to identify your identity.

The digital photo must have a resolution of 300 ppi (pixels per inch), a size of at least 8 MP (megapixels), and be in JPEG format with low compression (high quality).

- 8. If available upload valid copies of IELTS/TOEFL/Duolingo certificates.
- 9. Optional the applicant may upload a list of academic and research publications.

Additional requirements for international applicants:

- 10. Bank statement (not required for ethnic Kazakhs).
- 11. Certificate of no criminal record (in accordance with the Migration Law of the Republic of Kazakhstan).

STEP 2. DETERMINE YOUR ENGLISH LANGUAGE PROFICIENCY

To participate in the KEPT test, you will need a student ID number.

Getting it is very simple:

- Fill out the online application form on the applicant portal
- Upload a copy of your ID (both sides)
- Confirm your online application by clicking the SUBMIT APPLICATION button, even if you have not yet uploaded other required documents you can upload them later at any time

Once you complete these three steps, a student ID number will be assigned to you.

If you provide valid international certificates, you are exempt from taking the KEPT test.

*Educational documents issued by foreign educational institutions must be accompanied by a notarized translation into Kazakh or Russian and go through the nostrification/recognition procedure during the first academic semester. Attention! The table is valid for all programs except Educational Policy and Management (MEPM), Psychology (MSP), and International Law (MLLM). The minimum IELTS score for MEPM and MSP is 5.5, with no section lower than 5.0.

MLLM requirements: KEPT – 85, IELTS – 6.0 (with no section lower than 5.0), TOEFL iBT – 75, TOEFL CBT – 195 or higher, Duolingo – 110.

STEP 3. ENTRANCE EXAMS

3.1. COMPREHENSIVE TESTING (only for citizens of Kazakhstan)

According to the Model Rules for Admission to Master's Programs, approved by Order № 600 of the Minister of Education and Science of the Republic of Kazakhstan dated October 31, 2018, citizens of the Republic of Kazakhstan applying for master's programs are required to take the Comprehensive Testing (CT), developed by the National Testing Center (NTC).

Applicants to scientific and pedagogical master's programs are required to take a comprehensive test consisting of: a foreign language test, a test on the profile of the educational program group, a readiness-for-learning test.

Admission to master's programs is based on the results of the Comprehensive Testing (CT):



A minimum of **75** points is required for the MAFL program, including at least **25** points in the foreign language section, 7 points in the profile test with one correct answer, 7 points in the profile test with one or more correct answers, and 7 points in the readiness-for-learning test; a minimum of 30 points is required for all other programs, including at least 7 points in the profile test with one correct answer and 7 points in the profile test with one or more correct answers, with application deadlines for the CT determined by the Department of Higher and Postgraduate Education and published on the official website of the National Testing Center (NTC).

Applicants to the MBA program are exempt from taking the Comprehensive Testing (CT) and instead undergo entrance examinations determined by KIMEP University — an English language test (KEPT) and the KIMEP Graduate Entry Test (KGET) for MBA admission.

For KIMEP graduates:

- Graduates with a GPA of 3.0 or higher are exempt from internal KIMEP tests and the KGET (including the online interview)
- All KIMEP graduates are exempt from taking the KEPT English language test
- Credit transfer is available

STEP 4: SUBMIT THE AUTHENTIC DOCUMENTS

- Authentic copy of higher education diploma (with supplement) To the Medical Office of KIMEP:
- Medical Certificate the Form 075-y or its equivalent for foreign citizens. KIMEP Medical Center may request a notarized translation of the medical certificate equivalent, therefore it recommends international students to undergo a medical examination upon arrival to Almaty. The Form should include conclusions from a general practitioner, surgeon, neurologist, ENT-doctor and the results of micro-reaction blood test, as well as the original chest X-ray shot which should have two signatures and two stamps by doctors (the certificate is valid if issued no earlier than 6 months ago).
- Copy of vaccination record (only for applicants younger than 32 years of age).

STEP 5: LEARN ABOUT THE ADMISSION DECISION AND SIGN THE CONTRACT FOR EDUCATIONAL SERVICES

 - Read carefully: Go through the entire contract to ensure you understand all the terms and conditions.
 - Sign each page: Place your signature in the designated area on each page of the contract.
 - Scan the signed contract: Use a scanner or a scanning app on your phone to create a digital copy. Make sure all pages are clearly visible.
 - Upload the scan to the system: Go to the "Documents for upload" section and find the "SIGNED CONTRACT" field. Upload the scanned file there.
